PARTIES

This document is a Consent Agreement regarding the Driver/Trainer License of Andrew Harrington ("Trainer Licensee"). It is entered into between the Trainer Licensee, the Maine State Harness Racing Commission ("the Commission") and the Office of the Maine Attorney General ("Attorney General"). It is entered into pursuant to 8 M.R.S. § 279-B, and 01-017 C.M.R. Chapter 17.

STATEMENT OF FACTS

1. Trainer Licensee is so licensed by the Commission pursuant to 01-017 C.M.R. Ch. 1, Section 10, license number 18213.
2. Trainer Licensees licensed by the Commission are responsible for the condition of the horses they train pursuant to 01-017 C.M.R. Ch. 11, Section 1 and 4.
3. The Commission is authorized under 8 M.R.S. § 279-B, upon notice and hearing, to levy a fine, levy a suspension, disqualify a horse, and require the return of any purse won by a horse if it is found to have carried in its body either a prohibited substance or an exceedance of an allowable level of a permitted medication during any race licensed by the Commission.
4. Trainer Licensee was on record with the Commission as the trainer of the horse "Fern Hill Flight" on September 28, 2025, trainer of the horse "Arts Flight" on October 1, 2025, trainer of horse "Pax Hanover" on October 5, 2025, trainer of horse "Fern Hill Flight" on October 8, 2025, trainer of horse "Forrest Blu" on October 11, 2025, trainer of horse "moonlightandroses on October 11, 2025, trainer of horse "Fomor" on October 11, 2025, trainer of horse "Pax Hanover" on October 12, 2025 and trainer of horse "Mooss Trax" on October 12, 2025.
5. Fern Hill Flight finished first in the 7th Race at the First Tracks LLC, in Cumberland Maine on September 28, 2025, Arts Flight finished first in the 9th Race at the Fryeburg Fair, in Fryeburg Maine on October 1, 2025, Pax Hanover finished first in the 7th Race at the Fryeburg Fair, in Fryeburg Maine on October 5, 2025, Fern Hill Flight finished first in the 6th

Race at Bangor Raceway in Bangor Maine on October 8, 2025, Forrest Blu finished first in the 3rd Race at Bangor Raceway in Bangor, Maine on October 11, 2025, Moonlightandroses finished second in the 1st Race at Bangor Raceway in Bangor, Maine on October 11, 2025, Fomor finished second in the 8th Race at Bangor Raceway in Bangor, Maine on October 11, 2025, Pax Hanover finished third in the 3rd Race at Bangor Raceway in Bangor, Maine on October 12, 2025 and Mooss Trax finished third in the 11th Race at Bangor Raceway in Bangor, Maine on October 12, 2025.

6. Glycopyrrolate is a therapeutic medication.
7. A blood sample taken from Fern Hill Flight after the 7th Race on September 28, 2025, disclosed an elevated level of Glycopyrrolate. A blood sample taken from Arts Flight after the 9th Race on October 1, 2025, disclosed an elevated level of Glycopyrrolate. A blood sample taken from Pax Hanover after the 7th Race on October 5, 2025, disclosed an elevated level of Glycopyrrolate. A blood sample taken from Fern Hill Flight after the 6th Race on October 8, 2025, disclosed an elevated level of Glycopyrrolate. A blood sample taken from Forrest Blu after the 3rd Race on October 11, 2025, disclosed an elevated level of Glycopyrrolate. A blood sample taken from Moonlightandroses after the 1st Race on October 11, 2025, disclosed an elevated level of Glycopyrrolate. A blood sample taken from Fomor after the 8th Race on October 11, 2025, disclosed an elevated level of Glycopyrrolate. A blood sample taken from Pax Hanover after the 3rd Race on October 12, 2025, disclosed an elevated level of Glycopyrrolate. A blood sample taken from Mooss Trax after the 11th Race on October 12, 2025, disclosed an elevated level of Glycopyrrolate.

DISCIPLINARY COVENANTS

In order to fully resolve this matter without a formal adjudicatory hearing, it is hereby agreed that:

8. Trainer Licensee admits to the facts as stated above.
9. Trainer Licensee admits that Glycopyrrolate was found in the blood of Fern Hill Flight on September 28, 2025, at First Tracks LLC in Cumberland, Maine. Trainer Licensee admits that Glycopyrrolate was found in the blood of Arts Flight on October 1, 2025, at the Fryeburg Fair in Fryeburg, Miane. Trainer Licensee admits that Glycopyrrolate was found in the blood of Pax Hanover on October 5, 2025, at the Fryeburg Fair in Fryeburg, Maine. Trainer Licensee admits that Glycopyrrolate was found in the blood of Fern Hill Flight on October 8, 2025, at Bangor Raceway in Bangor, Maine. Trainer Licensee admits that Glycopyrrolate was found in the blood of Forrest Blu on October 11, 2025, at Bangor Raceway in Bangor, Maine. Trainer Licensee admits that Glycopyrrolate was found in the blood of Moonlightandroses on October 11, 2025, at Bangor Raceway in Bangor, Maine. Trainer Licensee admits that Glycopyrrolate was found in the blood of Fomor on October 11, 2025, at Bangor Raceway in Bangor, Maine. Trainer Licensee admits that Glycopyrrolate was found in the blood of Pax Hanover on October 12, 2025, at Bangor Raceway in Bangor, Maine. Trainer Licensee admits that Glycopyrrolate was found in the blood of Mooss Trax on October 12, 2025, at Bangor Raceway in Bangor, Maine.

10. Trainer Licensee admits that Glycopyrrolate was found in Fern Hill Flight, Arts Flight, Pax Hanover, Forrest Blu, Moonlightandroses, Fomor and Mooss Trax while racing during a licensed meet constitutes a violation of 01-017 C.M.R. Chapter 11.
11. Pursuant to 01-017 C.M.R. ch. 11, elevated levels of Glycopyrrolate is considered a Class 4 drug corresponding to a Class C penalty pursuant to 01-017 C.M.R. Chapter 17.
12. Trainer Licensee admits that the violation admitted herein constitutes a first violation carrying a Class C penalty within a 365-day period.
13. As discipline for the conduct admitted to in the paragraphs above, Trainer Licensee agrees to accept the following DISCIPLINARY ACTION:
 - A. A fine in the amount of \$500.00, of which is the recommended penalty for a Trainer Licensee for a first and second violation of 01-017 C.M.R. Ch.17, Class C Penalty over a 365-day period. The fine must be paid no later than five (5) days from the last dated signature on this consent agreement.
 - B. The return of the purse winnings for the violation which was, in this case, \$17,978.00. Such return of purse monies shall be made no later than five (5) days from the last dated signature on this Consent Agreement.
 - C. Should Licensee fail to return the \$17,978.00 purse winnings within five (5) days from the last dated signature on this Consent Agreement, licensee agrees to the immediate, automatic, indefinite suspension of his licenses until the \$17,978.00 purse winnings are paid in full.

FURTHER CONVENANTS

14. Trainer Licensee agrees that the Commission has regulatory authority over the activities described herein.
15. Entering into this Consent Agreement is fully voluntary. Trainer Licensee understands that instead of entering into this consent agreement, he can exercise his right to an adjudicatory hearing before any violations are found and penalties imposed.
16. Trainer Licensee expressly waives:
 - a. Notice of or opportunity for hearing
 - b. Any and all further procedural steps before the Commission;
 - c. The making of any further findings of fact before the Commission; and
 - d. The right to appeal this Agreement.
17. Violation of any of the terms or conditions of this Consent Agreement by Trainer Licensee shall constitute grounds for discipline, including but not limited to modification,

suspension, or revocation of licensure, the denial of licensure or re-licensure, and the imposition of civil penalties.


18. The Commission and the Attorney General may communicate and cooperate regarding any matter related to this Consent Agreement.
19. The Commission and Trainer Licensee agree that no further Commission action will be initiated against Trainer Licensee's license by the Commission based upon the specific violations admitted to herein, except or unless he fails to comply with the terms and conditions of this Consent Agreement. The Commission may however consider the conduct described above as evidence of a pattern of misconduct in the event that other allegations are brought against Trainer Licensee and this Consent Agreement will be admitted into evidence in any future hearing involving Trainer Licensee. The Commission may also consider the fact that discipline was imposed by this Consent Agreement in determining appropriate discipline in any further complaints against Trainer Licensee.
20. The parties agree that this Consent Agreement may be signed in counterparts, and all counterparts together constitute one original instrument. Signatures below may be applied and/or saved electronically, with such electronic signatures and this entire document being saved electronically and given the same effect as a paper document signed in ink.
21. This Consent Agreement is a public record within the meaning of 1 M.R.S. § 402 and will be available for inspection and copying by the public pursuant to 1 M.R.S. § 408-A.
22. Nothing in this Consent Agreement shall be construed to affect any right or interest of any person not a party hereto.
23. This Consent Agreement is not appealable and is effective until modified in writing or terminated by the parties hereto.
24. The effective date of this Consent Agreement shall be the date of the last necessary signature date of the fully executed Consent Agreement from the Commission.
25. Trainer Licensee acknowledges by his signature hereto that it has had an opportunity to consult with an attorney before executing this Consent Agreement, that he executes this Consent Agreement voluntarily, and that he agrees to abide by all terms and conditions set forth herein.




