1. Welcome and Introductions

Commissioner Whitcomb gave a brief operations report. He spoke upon the upcoming changes taking place within DACF as of October 9th set in motion by the legislature. Bob Marvinney will be the Director of the Bureau which LMF will now be a part. He also announced that the listing for the LMF Executive Director position will be posted soon. He spoke of funding challenges as there is no fund in place to pay for per diem expenses.

Mr. Meadows presented on the current available funds and bonds not sold yet.

Update on Closings

Mr. Meadows updated the Board on projects that have closed since the last meeting. These include Pleasant Bay Wildlife Management Area-Oscar Pond North parcel. Pending are: Scammon Farm, Sousa Property, J.O. Brown Working Waterfront and Maine Fresh Lobster Working Waterfront.

Mr. Meadows presented a spreadsheet on the projects that are anticipated to close in 2013 and expenses postponed to 2014.
