This letter is written in response to the expected impact the Bowers Mountain Wind Project may have on law enforcements services.

Currently Carroll Plantation receives its law enforcement services from both the Penobscot County Sheriff's Office and Maine State Police, through our resource sharing agreement.

I reviewed the project description and expect that any services the project will require will be consistent with services currently provided in this area. This project should have little impact on additional calls for service to Carroll Plantation.

Two factors that may impact the need for additional law enforcement services would be possible criminal mischief and trespassing that may occur on property designated for the project. Also the potential for additional services needed during informational meetings or protest.

One other concern raised was the possible obstruction of radio towers currently used for public safety functions

I believe the Penobscot County Sheriff's Office can provide adequate law enforcement services to Carroll Plantation and the Bower Mountain Wind Project.



This letter is in regards to the proposed Bowers Wind Project located in Kossuth Township, Washington County, Maine. It is my understanding the proposed Project will be located directly south of US Route 6 and would be using existing roads. The Project would have an operation and maintenance building north of US Route 6 and a substation located near the intersection of North Road and the existing # 56 transmission line.

Overall, we expect any services the project will require will be consistent with the services currently provided in northern Washington County. This project is likely to have little, if any, need for police services from the Sheriff's Office. There do not seem to be any unique safety risks that will need to be addressed and the police services currently provided will be adequate to ensure safety. The Washington County Sheriff's Office can provide adequate police services for the Bowers Wind Project.
