Growth Management Program Stakeholder Group

The Maine Office of Community Affairs (MOCA) has been tasked with convening a stakeholder group to support rulemaking related to the growth management law, which governs the comprehensive planning process in Maine municipalities. Pursuant to <u>P.L. 2025</u>, chapter 393, this stakeholder group will provide input on the content of the rules necessary to implement <u>Title</u> 30-A, chapter 187, subchapter 2: Growth Management Programs, as amended.

Timeline

GOVERNOR

- December 8, 2025, 1:00-3:00 pm First stakeholder meeting (weather date Dec 15)
- January April 2026 Ongoing monthly stakeholder meetings
- May 2026 Stakeholder report finalized
- Summer and Fall 2026 MOCA staff draft rules based on stakeholder input and solicit public input through formal rulemaking process including public hearing
- Winter 2026 rules reviewed by legislature for approval
- The changes to the comprehensive planning process will be optional for communities submitting plans until 24 months after the legislature's approval of the rules, at which point the new process will become mandatory.
