In this way, we hope to reduce the time and effort that your committee needs to spend on data collection, so that it can concentrate more on planning for your community's future.

### **What's Inside?**

The Resource Package contains a combination of raw data, analyzed data and technical assistance materials designed to help with the development of your comprehensive plan. Most of the data pertain specifically to your municipality. Once you become familiar with it, we believe you'll find the resource package to be extremely useful as you move through the comprehensive planning process.
