Re: Potential Ecological Reserve Addition at Salmon Brook Lake Bog

The purpose of this memo is to present a proposal to expand the Ecological Reserve at Salmon Brook Lake Bog Public Reserved Lands and to request your review and comment.

In March 2022, the Governor approved the legislature's revisions to 12 MRSA §1805 that modified the statutory limits on total acreage and operable timberland that may be designated as Ecological Reserve. As a result of the revisions, the total acres available for Ecological Reserve designation increased by 15,000 acres, and operable timberland available for designation increased by 8,626 acres.

This statutory change has provided the Bureau with the opportunity to provide the highest level of protection to additional ecologically important areas. In response, the Bureau, in collaboration with the Maine Natural Areas Program, identified several areas for new Ecological Reserve designation. In addition, members of the public with intimate familiarity with the ecological resources of the Salmon Brook Lake Bog unit have developed a proposal to expand the existing Ecological Reserve.

All these areas have been reviewed by the Ecological Reserves Scientific Advisory Committee.

This proposal would add the remaining 645 acres of the Salmon Brook Lake Bog unit to the existing 1,013-acre Ecological Reserve. The attached nomination document provides information on the specific ecological characteristics of the proposed addition and other details. [Note: the acreage figures in the nomination document differ from the figures above, as they are based on deed acres rather than the more accurate GIS data used by the Bureau.]

The Bureau requests that you review the nomination and respond by April 19 with any comments or questions.

If requested by Committee members, the Bureau would be happy to schedule a videoconference meeting to discuss the nomination and any concerns in more detail.

Following this review, the Bureau will prepare a Plan amendment that applies revised Resource Allocations to the final ecological reserve addition area. (In accord with the Integrated Resource Policy, the entire unit would be reallocated to Special Protection – Ecological Reserve; see the attached maps of the area, depicting the current allocations and allocation with the expanded Ecological Reserve.) A public meeting will then be scheduled to present and take comment on all proposed Plan amendments resulting from the new reserve designations.
