

Maine Weekly Influenza Surveillance Report

November 30, 2006

Synopsis


During the week ending November 25, 2006 (MMWR week 47)*, no influenza activity was reported in Maine.

Moderate Disease Surveillance

Outpatient influenza-like illness (ILI)

During the week ending November 25, 2006, 0.3% of sentinel provider outpatient visits were due to ILI (range 0% - 1.2%).

Maine, 2005-2007**




New England is defined as Connecticut, Maine, Massachusetts, New Hampshire, Rhode Island, and Vermont.

Severe Disease Surveillance

Hospital inpatients

During the week ending November 18, 2006 (week 46), 3.4% of admissions reported by four hospitals were due to respiratory illness (range 1.3% - 5.3%). During the week ending November 25, 2006 (week 47), 3.7% of admissions reported by three hospitals were due to respiratory illness (range 1.7% - 7.1%).

Laboratory Reporting

As of November 25, 2006 a total of 28 respiratory specimens have been submitted for viral testing to the Maine Health and Environmental Testing Laboratory. Nineteen specimens were negative for influenza, three specimens were presumptive positive for enterovirus, and results are pending for six specimens.


As of November 25, 2006, a total of 89 specimens have been submitted for viral testing to two reference laboratories in Maine; all were negative for influenza, two specimens were positive for RSV, seven specimens were positive for adenovirus, and seven specimens were positive for enterovirus.

Fatalities Surveillance

Death Certificates

During the week ending November 25, 2006, 7.7% of deaths reported by two city vital records offices were attributable to pneumonia and influenza.

Percentage of Deaths Attributable to Pneumonia and Influenza – Maine, New England and the United States, 2005-07





Pediatric Fatalities

As of November 30, 2006, no influenza-associated pediatric deaths have been reported in Maine this season.
